Administrative Order
#95-14

The Presiding Judge of the Superior Court in Mohave County, Arizona, finds as follows:

1. That ARS 8-237 authorizes the Superior Court to establish a public council or committee having as its object the prevention of juvenile delinquency and may cooperate with, or participate in, the work of any such council or committee for the purposes of preventing or decreasing juvenile delinquency, including the improving of recreational, health, and other conditions in the community affecting juvenile welfare.
2. That the Chief Justice of the Arizona Supreme Court has requested that all Superior Courts enlist community involvement and support in addressing issues related to juvenile crime.
3. That there is interest in soliciting community involvement in adult community corrections issues.

The forgoing findings having been considered,

IT IS ORDERED that effective May 15, 1995, the Mohave County Superior Court Community Advisory Board is established to create a forum for two-way communication and problem solving between the Superior Court and the community in regard to significant issues affecting the Juvenile Court and the probation department. The Community Advisory Board shall perform the following functions and responsibilities:

1. The MCPDCAB shall act as an advisory board making recommendations on ways the Mohave County Probation Department can continuously improve its services.
2. The MCPDCAB shall identify what the community wants from the Mohave County Probation Department .
3. The MCPDCAB shall evaluate what the community receives from the Mohave County Probation Department.

4. The MCPDCAB shall make recommendations on what the community should be getting from the Mohave County Probation Department.

5. The MCPDCAB shall act as a sounding board for new ideas from the community and the Mohave County Probation Department.

6. The MCPDCAB shall assist in the development of increased public understanding and support for the Mohave County Probation Department .

7. The MCPDCAB shall recommend legislative changes to the Presiding Judge of the Superior Court as appropriate.

8. The MCPDCAB shall recommend changes in Mohave County Probation Department polices or procedures as appropriate.


IT IS FURTHER ORDERED that the Mohave County Superior Court Community Advisory Board shall act in an advisory capacity only and shall have no authority to direct or control the Presiding Superior Court Judge, other Judges, the Director of Juvenile Court Services, Chief probation Officer or staff in any manner, nor control the administration of programs or to set policy.

IT IS FURTHER ORDERED that the Board shall consist of no less than 6 and no more than 12 members appointed by the Presiding Judge and shall conduct business in accordance with bylaws adopted by the Board and approved by the Presiding Judge.

IT IS FURTHER ORDERED appointing the following persons as members of the Mohave County Superior Court Community Advisory Board for the following terms:
