ADMINISTRATIVE ORDER

98-7

(Replacing Administrative Order 94-14)

WHEREAS, it is necessary for the Mohave County Committee on Court Automation to be restructured to meet its purpose and goals; and

WHEREAS, it is appropriate to appoint new members to this committee;

IT IS ORDERED that the Mohave County Committee on Court Automation is formalized as follows:

1. PURPOSE:

The Committee shall oversee the court automation project, resolve policy issues related to the project, and provide input into the use of the Court Automation Enterprise Fund. This shall include the purchase, installation and maintenance of required hardware, software, and related technology and professional services as may be required for the efficient installation, operation, and management of the project consistent with Mohave County budgetary policies and procedures.

2. MEMBERSHIP:

The membership of the Committee is attached as an Appendix.

3. MEETINGS:


Meetings shall be scheduled at the discretion of the Committee Chair.

4. STAFF:

The Court Administrator's Office shall provide staff support for the Committee and as feasible, may conduct or coordinate research related to the network as requested by the Committee.
